I. Street Committee

1. Federal Sign Reflectivity Requirement

The Federal Highway Administration requires local governments to adopt a traffic sign maintenance plan in 2014. Resolution #2014-16 was proposed to address that need. It requires a sign inventory to be completed in 2015, and an evaluation of all signs to be completed in 2016. All traffic signs must meet the new reflectivity standard by 2018.
