A SUCCESSFUL 2017

Council and staff were able to complete many projects during 2017.

- 1) The wayfinding signs throughout the downtown were replaced with a new design.
- 2) New SCADA computer control systems were installed at the water and wastewater plants.
- 3) Additional hanging flower baskets were installed in the downtown area.
- 4) The original YPCC loan was paid off early.
- 5) New playground fencing was installed around the center and east ward playgrounds.
- 6) New trail crossing markings were installed on Locust, Center and West streets.
- 7) An old backhoe was replaced with a new excavator.
- 8) Paying of the courthouse parking lot was completed and a new multi-space meter was installed.
- 9) Victorian streetlights were extended to the 200 block of South Center Street.
- 10) The gym floor at the YPCC was refurbished.
- 11) The Beech Street stormwater project at fairgrounds was completed.

Council Adopts 2018 Budget

Borough Council has adopted a \$5,633,840 budget for 2018. The budget avoids a tax increase for the 8th consecutive year. Although the staff expects to be very busy throughout the year with the

sewage improvement project, there are several projects planned in 2018 including:

- 1) A design will be completed for the refurbishing of the front of the municipal building.
- 2) A pickup truck and a van will be replaced in public works.
- 3) A new lowboy trailer will be purchased, and the old trailer converted to a stage for street bands.
- 4) Security systems at the water treatment plant will be upgraded.
- 5) Additional deck chairs will be added at the swimming pool.
- 6) A tractor mower will be replaced.
- 7) Flooring and a copier at the YPCC will be replaced.
- 8) Various water system repairs will be done as time allows.





GARBAGE COLLECTION

The 3-year contract with Lee Disposal for garbage collection expired at the end of 2017. Since Mr. Lee retired, Waste Management completed the contract for the last three months. Council recently awarded a bid for a new 3year contract to Pro Disposal of Portage Township. The new contract allowed the monthly charge to be decreased slightly, while making curbside recycling a weekly benefit instead of twice each month.

RELAXED WINTER PARKING REGULATIONS WILL CONTINUE

Good News! The relaxed winter parking regulations within Ebensburg Borough, first tried last winter, were successful, and will be continued through this winter.

The winter parking regulations will only be enforced when deemed necessary by staff. A notice will be placed on the borough's website, www.ebensburgpa.com, announcing when the regulations are or are not in force. The same notice will be on the borough's Facebook page.

For those that may not have access to the Internet, a call to the borough office at 472-8780 is all that will be necessary to verify whether vehicles parked on the street need to be moved. During business hours, staff will be able to answer the question. After hours, callers may press "5" and the recording will inform the caller if the regulations are in effect or not.

Winter parking restrictions will be placed in effect with every forecasted snowfall. Depending on conditions, the restrictions will often remain in effect for several days following a snowfall. Crews often work for several days to push snow back from the curbs, to clear intersections, and to clear slush from the streets. Residents will be required to move vehicles until such time that the announcement on the website and Facebook is again changed. It will be everyone's responsibility to verify the current enforcement status of the winter parking regulations. Remember... because it snowed two days ago and hasn't snowed since; the winter parking regulations may still be in effect. Check the website!

The relaxed winter parking regulations require the full cooperation of everyone. It is important that the public works crews are able to maintain clear streets during winter conditions. If the relaxation of enforcement causes problems in that regard, it will be necessary to return to daily enforcement. Please work with us so that we can maintain our streets in a safe manner, while minimizing the inconvenience to you and your neighbors of moving your vehicle twice each day.

DO NOT PARK DIRECTLY OPPOSITE ANOTHER PARKED CAR. WHEN PERMITTED TO PARK ON BOTH SIDES OF THE STREET, BE SURE TO STAGGER CARS SO THAT PLOWS, FIRE TRUCKS AND AMBULANCES WITH WIDE MIRRORS CAN GET THROUGH.

STREET TREE CARE

The Borough replaces more than a dozen street trees every year because of damage done by string trimmers and lawn mowers

You wouldn't think that a little piece of string could hurt a tree -- but string trimmers don't actually use soft string. Instead, they slice through weeds and other materials with a flexible but sturdy piece of thin nylon -- nylon that can easily slice through a tender sapling's trunk, or even the thick bark of an established tree.



Trees that have trimmer damage will suffer from dieback of branches, yellowing or prematurely dropping leaves, and other problems such as insect pest infestations or diseases, which can happen when insects and fungi or bacteria enter the heartwood of the tree through the wound. In most cases, any damage to the bark of a young tree will kill the tree.

Prevent weeds from growing near the trunk of your tree in the first place by encircling it with a nice, 2- to 4 -inch thick layer of mulch. The mulch will not only help prevent weed growth, but it will also help keep the soil moist and cool for the tree's benefit. The circle should be between 4 and 6 feet in diameter. Rake the mulch up to, but not touching, the trunk of the tree -- leave a couple of inches of bare ground around the trunk. No weed growth means no need to bring out the string trimmer. If you do have some weeds sneak through the mulch or grow right up next to the trunk, remove them by hand rather than with a trimmer.

Another option is to install a short piece of flexible tubing, sliced to allow expansion, around the base of the tree. The borough has recently installed those protective devices on all street trees.

Trees are a valuable asset to your property and are important to our environment. Every tree contributes to the urban forest and improves air and water quality in your neighborhood. Protect and preserve these growing assets by keeping mowing and weed-trimming equipment away from tree trunks. The damage lasts and it cannot be undone.

Chlorination Byproducts •

The Ebensburg Water System has had to notify customers over the past few months of an issue dealing with high levels of byproducts of the disinfection process. Those byproducts are Trihalomethanes (TTHM) and Haloacetic Acdis (HAA5).

Natural organic matter (NOM) is common in any surface water source. When combined with chlorine, byproducts such as TTHM and HAA5 are formed. The chlorine effectively treats the disease-causing microorganisms, but the disinfection byproducts are distributed throughout the system.

Time, temperature and pH contribute to the levels of byproducts. Ebensburg's Saltlick system is especially prone to higher levels of byproducts because of the low flows through that portion of the system. Longer storage times will contribute to higher levels of byproducts. Ebensburg already keeps the water level in the Ogden storage tank relatively low and regularly flows water from the system, but those efforts have not helped.

This problem is affecting only a handful of customers along the Route 22 corridor near the airport. That area is served by water purchased from the Greater Johnstown Water Authority's Saltlick Reservoir in Mineral Point. The remainder of our water system, including customers in the borough, are served by water from Ebensburg's own reservoirs, and treated at our own water treatment facility. Those customers are not affected at all by byproducts. Unfortunately, if the high level of byproducts are detected anywhere in the distribution system, then all customers on the system must be notified.

The Johnstown Water Authority is undertaking measures to assure that the water produced in their treatment process at the Saltlick reservoir contains the lowest levels of disinfection byproducts possible. But until the running annual average of those test results drops below the threshold for notification, we will need to continue issuing public notifications.

SEWAGE COLLECTION PROJECT

The much talked about sewage project is about to get underway! The design is completed, and DEP has issued all required permits. PENNVEST has approved a 1% loan covering 100% of the \$9 million project cost.

Bids for the project are being sought now, and a contract is expected to be awarded in February. Construction should begin in April, and will continue through June 2019.

Once construction begins, and as new sewage mains are installed, new taps will be provided for current customers. Current customers will not be required to pay new tapping fees. All customers will be required to have their sewer lateral (the private line between the house and the main) pressure tested. In most areas, we will not require any form of under-slab testing, but we will verify that all piping outside of the building's foundation is water-tight. We will also verify that all downspouts, driveway drains, footer drains, etc. are not connected to the sanitary sewer system.

Due to the age of the system, it is expected that most private sewer laterals will fail a pressure test and will require replacement up to the foundation. Property owners should begin planning for such an expense now. As main line construction is completed in areas, property owners will be notified when to initiate the repair or replacement and testing of their own sewer lateral, and will be provided with sufficient time to do so. The project will begin near Route 22 and move north through town.

NEW COUNCIL MEMBER ELECTED

At the end of 2017, Council member Joe Miller decided not to seek re-election, and his term on Council came to an end. Joe was recognized for his outstanding 12 years of service to Ebensburg, and the role that he played in improving our town.

Beginning a new term on Borough Council is Scot May. We wish him much success in his new role, and congratulate our reelected board members, Doug Tusing and Theresa Jacoby.

SEWER LINE TESTING

The initial notices requiring the testing/replacement of sewer laterals were mailed in March to customers in the Elderwood and Industrial Park sections of our service area. Those customers had until September 1st to bring their sewer laterals into compliance.

That notification went so well that the Municipal Authority decided to move ahead with compliance notices to all other non-project areas. Notices were mailed in August to customers north of Highland Avenue, along Manor Drive, Crestwood Estates, New Germany Road, Route 22 and Lovell Park sections. All customers in those areas were given until July 31, 2018 to gain compliance.

The sewer lateral line from the foundation wall to the property line shall be made to conform to current regulations including a cleanout near the foundation wall and a viewport at the property line. If a viewport already exists on the property, but is not visible or easily accessible, the owner must expose the viewport. If the existing sewer lateral fails the required pressure test, then the entire sewer lateral must be replaced or otherwise made to satisfy the air testing requirement. All required testing and work performed shall be inspected by the Borough while exposed.

The air pressure testing requirement applies to all components of the sewer lateral from the foundation wall to the connection stub. All components of the sewer lateral must be air tested by pressurizing with air to a minimum of five p.s.i. and thereafter held for a period of fifteen (15) minutes with no noticeable loss of pressure.

Customers who, for any reason, do not bring their private sewer lateral into compliance before the deadline will incur a 35% surcharge on their sewer bill.

Ebensburg does not require pressure testing under the basement slab, except in those rare cases where visual examination indicates the presence of stormwater. Complete information regarding sewer testing is available on the borough's website www.ebensburgpa.com. A sewer test application is also available on the website.

EBENSBURG WATER/SEWER CUSTOMERS

The Borough of Ebensburg and the Ebensburg Municipal Authority are not responsible for the backup of water or wastewater into residences, whether or not caused by blockages in the municipal system. Customers are cautioned that such backups will occur from time to time, and are advised to install a back flow prevention device to protect their personal property. Customers are further advised that homeowners insurance does not normally cover such a loss, but that additional coverage may be purchased to provide coverage for backup of water/ wastewater. Pro Disposal is proud to service Ebensburg Boro's trash and recycling needs beginning in January of 2018. All residents South of High Street will be serviced on Thursday and all residents North of High Street will be serviced on Friday. Your trash and recycle will be collected on the same day.

We also offer extra bags service At \$2 a bag which can be picked up at the Boro office.

The Ebensburg Borough Recyclable Collection Program asks all residents occupying single-family and multi-family dwellings of two and three units to recycle.

Place the Containers at the Curb: Pick-up requires that containers be placed at the curb by 6:00 am on the collection day. Where there is no curb, place containers next to the roadway or berm.

Holidays: If there is a holiday during the week of your scheduled collection pickup day, your pickup will be the next day. There is Saturday pickup.

Holidays that fall on a weekend will not affect weekly pickup.

RESERVOIR UPDATE -

The Ebensburg Water System is served primarily by two reservoirs north of town. The large upper reservoir has always been found to be in excellent condition. The smaller lower reservoir is also in excellent condition, but the drain valve required replacement.

The reservoir was drained at the end of 2016, and we hoped to install the new drain valve then. A series of issues has delayed the machining and delivery of the new valve, and the reservoir has remained drained during 2017. The lower reservoir is not relied upon for day-to-day operations. It is possible that, by the time this newsletter is published, the new drain valve will have been received and installed. If not, this project should be completed this spring, as soon as the reservoir floor is dry enough.
