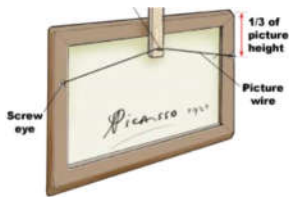

GUIDELINES

- ❑ Artwork submitted is original in design and created by the person entering.
- ❑ No more than TWO entries per artist are being submitted.
- ❑ NO wet pieces are being submitted.
- ❑ Framed artwork does NOT exceed 36" in height or width.
- ❑ Artwork has not been submitted in previous years.
- ❑ Subject matter is appropriate for public viewing. If you're not sure, ask.
- ❑ Artwork is properly framed, wired and ready for hanging as seen in diagram below. (Dimensional art is the ONLY exception).
- ❑ Artwork will be left on display for duration of show.
- ❑ Staff cannot transport artwork to or from show.
- ❑ Due to space limitations, entries/fees may be returned once show is full.



Picture should be wired as shown above. A screw eye/D-ring may be used on each side of the frame, & wire should be attached 1/3 of the way down. A D-ring alone will NOT be accepted.

If ANY of the above criteria are not met or any works misrepresented, the committee has the right to refuse your submission(s) to the show without a refund.

DATES & DEADLINES - NO EXCEPTIONS

Monday, April 1 - Deadline for applications

Thursday, April 25

- 5 pm - 7 pm: Hand deliver artwork to the Cambria County Courthouse

Saturday, April 26

- 12 pm - 6 pm: Exhibit open to the public
- 7 pm - 9 pm: Private Reception for Artists' Awards, Sponsors & Dignitaries

Sunday, April 27

- 11 am - 4 pm: Exhibit open to the public
- 4:30 pm - 5 pm: Artwork pick-up from Courthouse,

ARTWORK CATEGORIES

- **Painting** - Oil, Acrylic, Watercolor, etc.
- **Drawing** - Charcoal, pencil, pastels, pen & ink, etc.
- **Traditional Photography** - May be enhanced by brightness, contrast or color but has the appearance of a traditional photograph.
- **Dimensional** (not restricted by size limits) - Sculpture, Fiber Art, Ceramics.
- **Mixed Media** - Combination of two or more mediums (ex. Painting/drawing/photography with the use of computer software/digital, or another media)

All pieces must remain on display for the duration of the show. (Thursday - Sunday)

The EMP will provide security during exhibit hours through its volunteers. The Cambria County Board of Commissioners will also have officers on site during the exhibit hours. The Cambria County Courthouse is well-secured during non-exhibit hours. While great care will be taken with all works submitted, items that are damaged, lost or stolen during the course of the show are the responsibility of neither the EMP nor the County of Cambria. By submitting works, the artist accepts these conditions.

AWARDS

Three awards will be given in five categories.

1st Place - \$100

2nd Place - \$75

Honorable Mention - \$50

Awards will also be given for:

Best of Show - \$125

People's Choice - \$75

An independent juror will determine the award winners.

The Mayor of Ebensburg will also be giving three special awards:

Artwork inspired by the town of Ebensburg.

Mayor's Overall Favorite

Mayor's Honorable Mention
