**PART 1**

**GENERAL REGULATIONS**

**§11-101. Definitions and Interpretations**

- A. Words and phrases, when used in this Chapter, except for Sections or parts to which different or additional definitions apply, shall have the meanings ascribed to them in the Vehicle Code, 75 Pa.C.S.A. §101 et seq., except that in this Chapter the word "street" may be used interchangeably with the word "highway," and shall have the same meaning as the word "highway" as defined in the Vehicle Code.
- B. The term "legal holidays" as used in this Chapter shall mean and include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.
- C. In this Chapter, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.
- D. The term "parking meter" shall also be interpreted to apply to parking meter pay stations.

**§11-102. Manner of Adopting Permanent Traffic and Parking Regulations**

All traffic and parking regulations of a permanent nature shall be enacted as ordinances, as parts of ordinances, as amendments to ordinances or as amendments to this Chapter, except where the law specifically authorizes less formal action.

**§11-103. Provisions to be Continuation of Existing Regulations**

The provisions of this Chapter, so far as they are the same as those of ordinances and regulations in force immediately before the enactment of this Chapter, are intended as a continuation of those earlier ordinances and regulations, and not as new enactments. Nothing in this Chapter shall affect any act done or liability incurred, or any suit or prosecution pending or to be instituted under any of those repealed or superseded ordinances or regulations.

**§11-104. Temporary and Emergency Regulations**

- A. The Chief of Police shall have the following powers to regulate traffic and parking temporarily and in time of emergency:
  - 1. In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations.

2. In the case of emergency or to facilitate public works, or in the conduct of parades, processions or public events, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.

- B. Such temporary and emergency regulations shall be enforced by the Police Department in the same manner as permanent regulations. Any person who shall operate or park a vehicle or tractor in violation of any such regulation, or who shall move, remove, destroy, insure or deface any sign or marking erected, posted or made to give notice of any such regulation, shall, upon conviction thereof, be subject to the penalty set forth in the law or elsewhere in this Chapter for a violation of such nature and, in case of a violation for which no specific penalty is set forth in the law or elsewhere in this Chapter, to a fine of not more than \$25 together with costs of prosecution.

#### **§11-105. Experimental Regulations**

The Borough Council may, from time to time by resolution, designate places upon and along the highways in the Borough where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect, and shall designate such locations by proper signs and markings. Such regulations, prohibitions and restrictions shall be effective as if they had been specified in this Chapter. No person shall operate and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this Section. Any person who shall violate any provision of this Section shall, upon conviction thereof, be subject to the penalty set forth in the law or elsewhere in this Chapter for a violation of such nature and, in case of a violation for which no specific penalty is set forth in the law or elsewhere in this Chapter, to a fine of not more than \$25 together with costs of prosecution; provided, the purpose of this Section is to allow for test and experimental determination of the feasibility and desirability of permanent changes in the ordinances of the Borough relative to traffic and parking.

#### **§11-106. Traffic on Streets Closed or Restricted for Construction, Maintenance or Special Events**

- A. The Borough Council shall have authority to close any street or specific part of a street to vehicular traffic and to place barriers or station police officers at each end of the closed portion while construction or maintenance work is under way or a special event is being conducted on the closed portion. It shall be unlawful for any person to drive a vehicle upon any such closed portion.
- B. The Borough Council shall have authority to establish a restricted traffic area upon any street where construction or maintenance work is under way and to station flagmen at each end of the restricted portion. It shall be unlawful for any person to drive a vehicle upon any such restricted traffic area at any time when the flagman is displaying a sign directing that vehicle to stop, or is signaling that vehicle, by a flag or other device, not to proceed.
- C. Any person who violates any provision of this Section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

**§11-107. Use of Streets By Processions and Assemblages**

- A. For the purpose of this Section, the words "assemblage" and "procession" shall have the following meanings:

ASSEMBLAGE – a gathering of people without vehicles, which interferes with the movement of pedestrian or vehicular traffic on any street.

PROCESSION – a group of individuals, vehicles, animals and/or objects moving along a street in a way that interferes with the normal movement of traffic. A procession shall not include a funeral caravan or military convoy.

- B. It shall be unlawful for any person to hold or participate in any assemblage unless the person organizing or conducting the assemblage first obtains a permit from the Chief of Police, which shall be issued without fee. Application for the permit shall be made at least 1 week in advance of the day on which the assemblage is proposed to be held, but in any case where a State-designated highway is proposed to be used, application shall be made at least 3 weeks in advance of the proposed date. The permit shall state the place where and the date when the assemblage is to be held, the hour when the assemblage may convene and the hour by which it shall have been completely dispersed. It shall be unlawful for any person to hold or to participate in any assemblage unless the permit has been granted, or at any time or place other than that authorized by the permit.
- C. It shall be unlawful for any person to hold or participate in any procession unless the person organizing or conducting the procession first obtains a permit from the Chief of Police, which shall be issued without fee. Application for the permit shall be made at least 2 weeks in advance of the day when the procession is proposed to be held, but in any case where the State-designated highway is proposed to be used, application shall be made at least 3 weeks in advance of the proposed date. The permit shall specify the date on which the procession is to be held, the route to be followed by the procession, the hour when and place where participants may commence to assemble and form before the procession is under way, the time when the procession may commence to move along its route, and the time by which the end of the procession shall have been disbanded. It shall be unlawful for any person to hold or to participate in any procession unless the permit shall have been granted, or under any conditions as to time or route or otherwise than those stated in the permit.
- D. Any person who violates any provision of this Section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

**§11-108. Authority of Police Officers**

The police officers of the Borough are hereby authorized to direct traffic on the highways of the borough and at intersections thereof and to otherwise enforce the provisions of this Chapter.

**§11-109. Authorization for Use of Speed Timing Devices**

- A. The Police Department is hereby authorized to use all speed timing devices for the determination of speed of a motor vehicle as are approved or will be approved by the Department of Transportation of the Commonwealth of Pennsylvania, in accordance with 75 Pa.C.S.A. §3368.
- B. This Section authorizes the use of said devices upon all highways within the Borough be they Borough, County or State highways, and does also hereby elect to exercise all powers granted to "local authorities" under the Vehicle Code of the Commonwealth of Pennsylvania, 75 Pa.C.S.A. §6101 et seq., as hereafter amended, supplemented, modified or reenacted by the General Assembly of Pennsylvania.

**§11-110. Establishment of the Position of Parking Enforcement Officer**

- A. The position of Parking Enforcement Officer is hereby created.
- B. Duties – The duties of the Parking Enforcement Officer shall be to enforce all parking regulations within the Borough. Duties shall be performed under the supervision of and in accordance with all instructions, established routines and guidelines of the Chief of Police.
- C. Authority – The Parking Enforcement Officer shall have the authority to issue parking tickets and enforce all Ebensburg Borough parking regulations and ordinances, including instituting on behalf of the Borough summary criminal proceedings before a Magisterial District Judge, and representing the Borough at such proceedings.

- A. At the following locations traffic signals as indicated below shall be erected (or are ratified if previously erected), and traffic at those locations shall be directed by those signals:

**§11-202. Intersections Where Turn Prohibited on Red Signal**

- A. The following are established as intersections where drivers of vehicles headed in the direction or directions indicated are prohibited from making a right turn (or a left turn from a one-way street into another one-way street) on a steady red signal:

**§11-203. One-Way Roadways Established**

- A. The following are established as one-way roadways, and it shall be unlawful for any person to drive a vehicle on any one-way street other than in the direction established for traffic on that street:

**§11-204. Stop Intersections Established**

- A. The following intersections are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second-named street (the intersecting or through street) on the first-named street (the stop street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first-named or stop street, in the direction indicated in each case, shall stop the vehicle as required by §3323(b) of the Vehicle Code, 75 Pa.C.S.A. §§3323(b), and shall not proceed into or across the second-named or intersecting or through street until he has followed all applicable requirements of that Section of the law.

### **§11-205. Operation of Motor Vehicles Restricted on Public Lands**

- A. No motor vehicle including a motorcycle, pedalcycle or minibike shall be operated on any property owned by the Borough or any other public agency or instrumentality within the Borough without the permission of the property owner and a permit from the Chief of Police of the Borough.
- B. Any person who violates an provision of this Section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

**§11-206. Snowmobile Roads Designated**

A. The following roads and streets within the Borough are designated as special snowmobile roads:

B. It shall be unlawful for any person to operate a snowmobile on any highway, street or road in the Borough other than as provided above. Provided, nothing in this Section shall prohibit any person from operating a snowmobile on any other street in the Borough:

1. As authorized by §7721 of the Vehicle Code, 75 Pa.C.S.A. §7721, for emergency and bridge crossings and for direct crossing of streets or two-lane highways.
2. For special snowmobile events where authorized in advance and the street is blocked off as provided in §7723 of the Vehicle Code, 75 Pa.C.S.A. §7723. Any person who violates any provision of this Section shall be subject to the penalties prescribed in §7752(a) of the Vehicle Code, 75 Pa.C.S.A. §7752(a).

**PART 3****GENERAL PARKING REGULATIONS****§11-301. Vehicles to be Parked Within Marked Spaces**

Wherever a space is marked off on any street for the parking of an individual vehicle, every vehicle parked there shall be parked wholly within the lines bounding that space, and it shall be a violation of this Part for any person to park a vehicle or allow it to remain parked otherwise.

B. Time Limited Parking - Parking shall be limited to specific periods of time at locations designated by specific signs such as, but not limited to, “15 Minute Parking”.

C. Reserved Parking – Parking shall be prohibited at all times at locations designated by specific signs reserving a specific parking space for a specific individual or for a specific purpose.

D. Handicapped Parking - The Borough Council, at its discretion, may provide, at convenient and suitable locations reserved parking spaces for handicapped, and shall designate those spaces by appropriate signs. It shall be unlawful, and a violation of this Part, for any person to park in any such reserved parking space any vehicle unless that vehicle bears or displays either a "handicapped registration plate," a "handicapped parking placard," a "disabled veteran registration plate" or a "disabled veteran placard."

**§11-401. Parking Meter Zones Established**

A. Parking meter zones are established upon and along certain streets in the Borough as follows:

Parking meters shall be operated by the deposit of currency or other applicable means in the meter as prescribed by §11-405 and the parking rates for specified lengths of time, as prescribed in §11-401(B) shall apply at all times between the hours of 9:00 a.m. and 5:00 p.m. Monday through Friday. Provided, however, the requirements of this Part as to payment in meters or pay stations shall not apply on legal holidays.

**§11-403. Placement and Characteristics of Parking Meters**

Every vehicle parked at any metered parking space shall be parked wholly within the lines or markings so placed and applicable to that meter. It shall be unlawful and a violation of this Part for any person to park a vehicle across any

such line or marking, or to park a vehicle in such a position that the vehicle is not wholly within the area designated by those lines or markings.

B. Marked Spaces in Non-Metered Zones - Lines and/or markings may be painted or placed, only by or under the direction of Borough personnel, upon the curb, sidewalk or roadway for the purpose of delineating an approved parking space. Every vehicle parked at any marked space shall be parked wholly within the lines or markings so placed. It shall be unlawful and a violation of this Part for any person to park a vehicle across any such line or marking, or to park a vehicle in such a position that the vehicle is not wholly within the area designated by those lines or markings.

C. Private citizens are prohibited from painting or placing lines and/or markings for the purposes of delineating parking spaces or limiting parking.

**§11-405. Currency Deposit in Meter; Overtime Parking Unlawful**

Whenever a vehicle is to be parked in any space adjacent to a parking meter or regulated by a pay station, at any time in the period of limited parking as prescribed by §11-402, the driver of the vehicle, upon entering the parking space, shall immediately deposit, or cause to be deposited, in that parking meter or pay station the form of currency as specified in the legend on the parking meter or pay station. Upon the deposit of such currency, and placing the meter in operation, or, in the case of a pay station, displaying a receipt on the dashboard of the parked vehicle, the parking space may be lawfully occupied by the vehicle for the time indicated on the meter or the receipt. If any vehicle shall remain in any such parking space for any length of time that the meter or receipt shall indicate by proper signal that the lawful parking time has expired, that vehicle shall be considered as having been parked overtime, and the parking of a vehicle overtime shall be a violation of this Part. Every hour that a vehicle remains unlawfully parked in a metered parking space shall constitute a separate violation of this Part.

  4. Any other facts, the knowledge of which is necessary for a thorough understanding of the circumstances attending the violation.

The police officer or Parking Enforcement Officer shall also place on or attach to the vehicle a notice to the owner or driver of the vehicle that the vehicle was parked in violation of this Part, and instructing the owner or driver that if he will report to the office of the Chief of Police and pay, for the use of the Borough, the sum of \$5 within 7 days after the time of the notice, or will place the sum of \$5 enclosed within the envelope provided, in any of the special parking fine boxes installed at various locations within the Borough within the time limit, that act will save the violator from prosecution and from payment of the fine prescribed in §11- 410(A).

Part. Every hour that a vehicle remains unlawfully parked in a metered space shall constitute a separate violation of this Part.

This Part is enacted under authority of §6109(a)(22) of the Vehicle Code, 75 Pa.C.S.A. §6109(a)(22) and gives authority to the Borough to remove and impound those vehicles which are parked in violation of parking regulations of this Chapter. Vehicles which have been abandoned (as defined by the Vehicle Code) or which are parked in such a manner as to interfere with traffic or pose a hazard to others may be towed under the provisions of the Vehicle Code.

**§11-602. Authority to Remove and Impound**

The Borough shall have authority to remove and impound, or to order the removal and impounding, of any vehicle parked overtime or otherwise illegally; provided, that the circumstances of its parking were within the conditions stated in §11-601. Provided, no such vehicle shall be removed or impounded except in strict adherence to the provisions of this Part or the provisions of the Vehicle Code.

**§11-603. Tow Away Zones Designated**

The following designated streets and/or parking lots are hereby established as tow-away zones. Signs shall be posted to place the public on notice that their vehicles may be towed for violation of Borough parking regulations:

All parking lots established under §11-501.

The parking lot at the rear of the municipal building, 300 West High Street.

**§11-604. Designation of Approved Storage Garages; Bonding; Towing and Storage**

Removal and impounding of vehicles under this Part shall be done only by "approved storage garages" that shall be designated from time to time by the Borough Council. Every such garage shall submit evidence to the Borough Council that it is bonded or has acquired liability insurance in an amount satisfactory to the Borough Council as sufficient to indemnify owners of impounded vehicles against loss or damage to those vehicles while in the custody of the garage keeper for the purpose of towing or storage. The approved storage garage shall submit to the Borough Council its schedule of charges for towing and storage of vehicles under this Part and, when the schedule is approved by the Borough Council, those charges shall be adhered to by the approved storage garage; no different schedule of charges shall be demanded of or collected from any person whose vehicle is removed or impounded under this Part by any approved storage garage. The Borough Council shall delete from its list of approved storage garages any garage that makes any unapproved charge in connection with any vehicle removed or impounded under this Part.

**§11-605. Payment of Towing and Storage Charges**

The payment of towing and storage charges shall not relieve the owner or driver of any vehicle from liability for any fine or penalty for the violation of the provision of this Part for which the vehicle was removed or impounded.

**§11 -606. Reclamation Costs**

In order to reclaim his vehicle, the owner shall pay towing and storage costs plus a \$25 fee, of which \$10 shall be transferred to the Pennsylvania Department of Transportation by the garage to which the vehicle was taken.

**§11-607. Records of Vehicles Removed and Impounded**

The Borough shall cause a record to be kept of all vehicles impounded under this Part and shall be able at all reasonable times to furnish the owners or the agents of the owners of those vehicles with information as to the place of storage of the vehicle.

**§11-608. Restrictions Upon Removal of Vehicles**

No vehicle shall be removed under the authority of this Part or the Vehicle Code if, at the time of the intended removal, the owner or the person for the time being in charge of the vehicle is present and expresses a willingness and intention to remove the vehicle immediately.

**§11-609. Penalty for Violation**

Any person who shall violate any provision of this Part shall, upon conviction thereof, be sentenced to pay a fine of \$50 together with all costs of disposing of the vehicle under the provisions of the Vehicle Code, 75 P.S. §7301 et seq.

**§11-610. Reports and Disposition of Unclaimed Vehicles**

If after a period of 15 days the vehicle in storage remains unclaimed, a report shall be filed with PennDOT in accordance with §7311 of the Vehicle Code, 75 Pa.C.S.A. §7311, by the person having legal custody of the vehicle. If the vehicle has not been claimed after 30 days, the vehicle may be transferred to a licensed salvor who will then be responsible for filing the proper reports and disposing of the vehicle in accordance with the provisions of Chapter 73 of the Vehicle Code, 75 Pa C.S.A. §7301 et seq.

**PART 7  
SNOW AND ICE EMERGENCY**

**§11-701. Declaration of Snow and Ice Emergency**

In order to facilitate the movement of traffic and to combat the hazards of snow and ice on the snow emergency routes named in §11-703, the Chief of Police, the Mayor or the Borough Manager, in his or her discretion, may declare a snow and ice emergency (designated in this Part as a "snow emergency"). Information on the existence of a snow emergency shall be given by the Borough through radio, newspaper, television or other available media, and information on the termination of the emergency may be given by use of the same media.

**§11-702. Parking Prohibited, Driving Motor Vehicles Restricted On Snow Emergency Routes During Emergency**

After any snow emergency is declared, it shall be unlawful at any time during the continuance of the emergency for any person:

- A. To park a motor vehicle or to allow that vehicle to remain parked anywhere on any snow emergency route designated in §11-703.
- B. To drive any motor vehicle on any such snow emergency route unless that vehicle is equipped with snow tires or chains.

The following are designated as snow emergency routes:

- Marian Street (entire length)
- Julian Street (entire length)
- Center Street (entire length)
- Caroline Street (entire length)
- Phaney Street (entire length)
- Highland Avenue (entire length)
- Horner Street (entire length)
- Crawford Street (entire length)
- Sample Street (entire length)
- High Street (entire length)
- Lloyd Street (entire length)
- Ogle Street (entire length)
- Triumph Street (entire length)
- Prave Street (entire length)

**§11-704. Penalty for Violation**

Any person who violates any provision of this Part shall, upon conviction, be sentenced to pay a fine of not more than \$35 and costs. Provided, it shall be the duty of the police officers and of parking enforcement personnel of the Borough to report to the appropriate official all violations of any provision of this Part indicating, in each case, the Section violated; the license number of the vehicle involved in the violation; the location where the violation took place; and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation. The police officer or other person making the report shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation of this Part. The notice shall contain instructions to the owner or driver of the vehicle that if he will report to the office of the Chief of Police and pay the sum of \$15 within 7 days after the time of the notice, or if he will place the sum of \$15 enclosed within the envelope provided in any of the special parking fine boxes installed at various locations within the Borough, that act will save the violator from prosecution and from payment of the fine and costs prescribed in the first sentence of this Section.

**PART 8  
PEDESTRIAN REGULATIONS**

**§11-801. Pedestrians to Obey traffic-Control Signs**

At all locations in the Borough where official traffic-control signals are installed, pedestrians, except where directed otherwise by pedestrian-control signals installed under §11-802, shall obey the directions of those traffic-control signals, as follows:

- A. When facing a green signal, a pedestrian may proceed across the roadway within a crosswalk.
- B. When facing a steady yellow signal, a pedestrian shall not start to cross the roadway.
- C. When facing a steady red signal, a pedestrian shall not enter the roadway.

**§11-802. Pedestrian-Control Signal Locations Established**

- A. At the following locations, official pedestrian-control signals shall be erected (or are ratified if previously erected):

**Location**

Center Street and High Street  
Center Street and Highland Avenue  
Rowena Drive at Manor Drive  
West High Street at Ben Franklin Highway

- B. Every pedestrian facing a steady or flashing "Don't Walk" signal shall obey the directions of that signal, as follows:
  1. When facing a steady "Don't Walk" signal, a pedestrian shall not start to cross the roadway in the direction of the signal, but any pedestrian who has partially completed his crossing on the "Walk" signal should proceed to a sidewalk or safety zone while the "Don't Walk" signal is showing.
  2. When facing a flashing "Don't Walk" signal, a pedestrian shall not start to cross the roadway in the direction of the indication, but any pedestrian who has partly completed crossing during the "Walk" indication should proceed to a sidewalk or safety zone.

Any pedestrian who fails to obey the directions of a "Don't Walk" signal, as indicated above, shall be guilty of an offense and a violation of this Part.

**§11-803. Penalty for Violation**

Any pedestrian who violates any provision of this Part shall be guilty of a summary offense and, upon conviction, shall be sentenced to pay a fine of \$5 and costs.

**PART 9  
PEDALCYCLES AND NONMOTORIZED VEHICLES**

**§11-901. Skates, Skateboards, Coasters, Sleds and Other Toy Vehicles**

- A. It shall be unlawful for any person to ride on a sled upon any sidewalk in the Borough of Ebensburg, or upon any roadway unless that roadway is on a portion of a street blocked off for sledding by authority of §11-105 of Part 1 of this Chapter. Provided: nothing in this subsection shall prevent a pedestrian from pulling a sled, with or without a rider, upon a sidewalk.
- B. It shall be unlawful for any person to engage in roller-skating, skateboarding or to ride upon or propel any coaster or other toy vehicle upon:
  - 1. Any street except in order to cross the roadway.
  - 2. Any sidewalk located in the central business district, as described in the Ebensburg Zoning Ordinance, except that nothing in this Section shall prevent a pedestrian from pulling a coaster or other toy vehicle, with or without a rider, upon a sidewalk.
- C. Any person who violates any provision of this Section shall, upon conviction, be sentenced to pay a fine of \$5 and costs.
