<u>Recommended Action</u> – Award a bid to Sports & Recreation in the amount of \$11,820 for items 1-4, and to International Design in the amount of \$1,720 for Item 5 for playground equipment at the swimming pool and Lake Rowena.

# 7. STREET COMMITTEE

\* Item 7A: East Ogle Street Sidewalk The contractor began work on his project on May 13<sup>th</sup>. Courthouse staff has been cooperating with the inconvenience.

<u>Recommended Action</u> – No action required.

#### Item 7B: Sidewalk Ordinance Amendment

Ordinance #513 of 2003 designated the areas where sidewalks are required. It has been amended twice to reflect new sidewalks completed and planned.

Ordinance #605 was proposed last month, amending it again to reflect changes already made on South Cherry Street, and plans for future sidewalk improvements.

There are two clarifications to be made, both affecting West Triumph Street. First, the description in last month's agenda erroneously stated that sidewalks were proposed on both sides of West Triumph Street between Center Street and Marian Street. Ordinance #605 requires sidewalks on only one side of that segment of West Triumph Street, and that was the staff's intention. Second, Ordinance #605 indicated that sidewalks would be required on the north side of that segment of West Triumph Street, when in fact they would be required on only the south side, where an old sidewalk currently exists. Only the 100 block would have sidewalks on both sides.

While this might be a minor change to the overall Ordinance, it is a significant change to those that live on West Triumph Street. Staff recommends that the proposed Ordinance be readvertised prior to final adoption to reflect this change, as well as any other changes that Council might desire.

<u>Recommended Action</u> – Grant tentative approval to Ordinance #605, as amended, and advertise for public inspection.

#### Item 7C: Street Paving

Bids for resurfacing streets and the municipal parking lot are due on June 3<sup>rd</sup>. If the sidewalk project on Ogle Street goes faster than expected, staff may request that Council have a special meeting to award the paving bids instead of waiting until June 24<sup>th</sup> and leaving high curbs on Ogle Street well into July.

Staff has begun the preparatory work on the municipal parking lot.

Recommended Action - No action required.

#### Item 8A: Non-Uniform Pension Plan Restatement

Following a recent resignation of a non-vested employee, Mockenhaupt Associates realized that the non-uniform pension plan lacks language prescribing how the contributions made by the employee were to be refunded to the employee. Mockenhaupt prepared that pension amendment, and at the same time revised the document to incorporate the current requirements for "qualified" government pension plans pursuant to §401(a) of the IRS Code, including recent required amendments for the Economic Growth and Tax Relief Reconciliation Act of 2001, the Pension Protection Act of 2006, and the Heroes Earnings Assistance and Relief Tax Act of 2008.

<u>Recommended Action</u> – Grant final approval to Ordinance #606 restating the non-uniform Pension plan, incorporating changes relative to refunding of employee contributions and incorporating recent IRS amendments.

#### Item 9F: Electric Service

In September 2010, Council contracted with Champion Energy for supplying electricity on our five largest accounts. That 3-year contract will expire later this year. Energy costs are relatively low now and are expected to rise, and it is to the Borough's advantage to seek a supplier now and lock in the lower rate.

The lowest cost option secured by Smith Energy, our energy broker, is through First Energy. The cost for one year is 7.78¢/kW. Our current cost is 7.10¢ with Champion. Staff recommends that Council approve a 1-year contract with First Energy.

<u>Recommended Action</u> – Approve a 1-year contract for energy supply with First Energy at the rate of 7.78 e/kW, expiring December 2014.
