Item 1A: Tax Collector

Liam Anderson has resigned as local tax collector, effective August 29. After the position was advertised, former tax collector Charlene Remillard expressed her willingness to fill the position until at least the end of the year. However, the appointment will actually be through 2015, the next municipal election when the position will appear on the ballot for a 2-year term.

If Council chooses to appoint Remillard, staff will inform any other applicants that their applications will be held on file in the event needed again at the end of the year.

<u>Recommended Action #1</u> – Accept the resignation of Liam Anderson as local tax collector, effective 8/29/14.

<u>Recommended Action #2</u> – Appoint Charlene Remillard as local tax collector, effective 9/8/14.

Recommended Action #3 – Adopt Resolution #2014-09 authorizing office staff to receive and receipt tax payments on behalf of the tax collector.
