


LOCATION MAP

- . SLANTED LETTERING OR SHADING DENOTES EXISTING FEATURES OR FACILITIES.
- 2. VERTICAL LETTERING DENOTES PROPOSED FEATURES OR FACILITIES.
- 3. THE CONTRACTOR SHALL EXERCISE CAUTION AND EMPLOY CAREFUL EXCAVATION METHODS DURING INSTALLATION OF THE FACILITIES TO AVOID DAMAGE TO OR CONFLICT WITH EXISTING UTILITIES. - 5. EXISTING SEWERS AND WILDCAT SEWERS ARE SHOWN FOR GENERAL INFORMATION ONLY, BASED UPON LIMITED DATA. NO GUARANTEE IS MADE TO HORIZONTAL OR VERTICAL ALIGNMENT, PIPE SIZE, OR PIPE TYPE. LOCATION OF EXISTING SANITARY SEWERS AND WILDCAT SEWERS WERE BASED ON LOCATION OF EXISTING MANHOLES AND CLEANOUTS AND ASSUMING STRAIGHT RUNS BETWEEN THEM. THEREFORE, THE CONTRACTOR IS CAUTIONED THAT ACTUAL FIELD LOCATION OF THE PIPING MAY DEVIATE FROM THAT SHOWN AND NO ADDITIONAL PAYMENT SHALL BE MADE AS A RESULT OF ANY DEVIATION THEREFROM.
- 6. EXISTING TOPOGRAPHIC INFORMATION TAKEN FROM AERIAL PHOTOGRAPHY FLOWN ON (month. day. year). AND LIMITED FIELD SURVEYS PERFORMED BY STIFFLER, McGRAW & ASSOCIATES, INC.
- 7. PROPERTY LINES & RIGHT-OF-WAYS ARE SHOWN FOR INFORMATION PURPOSES ONLY AND DO NOT CONSTITUTE FIELD SURVEYS.
- 8. A MINIMUM 18" VERTICAL SEPARATION SHALL BE MAINTAINED BETWEEN THE SANITARY SEWER AND ANY CROSS PIPES OR THE SANITARY SEWER SHALL BE ENCASED IN CONCRETE PER ENCASEMENT DETAIL.
- 9. NO EXCAVATED, BORROW, OR BACKFILL MATERIAL SHALL BE STOCKPILED WITHIN THE 100-YEAR FLOODWAY OR FLOODPLAIN.
- 10. ALL SURFACES SHALL BE RESTORED TO PRE-CONSTRUCTION OR BETTER CONDITION.

- 15. CONTRACTOR SHALL PROVIDE SHORING, BRACING AND ANY OTHER MEASURES NECESSARY TO PREVENT DAMAGE TO EXISTING BUILDING FOUNDATIONS.
- 16. CONTRACTOR TO PERFORM CONSTRUCTION STAKEOUT AND CONFIRM ALL ELEVATIONS AND SLOPES PRIOR TO CONSTRUCTION. ALL DISCREPANCIES SHALL IMMEDIATELY BE REPORTED TO THE ENGINEER.
- 17. NO ADDITIONAL PAYMENT SHALL BE MADE FOR ROCK EXCAVATION.
- 18. CONTRACTOR SHALL TAKE ALL PRECAUTIONS NECESSARY TO PREVENT DAMAGE TO EXISTING FEATURES OR STRUCTURES.
- 19. CONTROL OF SEWAGE FLOW OF THE WILDCAT SEWERS AND EXISTING SANITARY SEWERS DURING EXECUTION OF THE WORK IS THE RESPONSIBILITY OF THE CONTRACTOR, AND SHALL BE BYPASSED VIA THE SANITARY SEWER. NO SURFACE OR SUBSURFACE DISCHARGES ARE PERMITTED. THE SUCCESSFUL BIDDER MUST SUBMIT AND GAIN APPROVAL OF A PLAN BY EBENSBURG MUNICIPAL AUTHORITY PRIOR TO INITIATION OF WORK.
- 20. LOW PRESSURE AIR TESTS WILL BE REQUIRED ON ALL NEW SEWAGE MAINS AND LATERALS.
- 21. NO CONCRETE CRADLES ARE SHOWN ON THE PLAN OR PROFILE. LOCATION OF CRADLES TO BE INSTALLED AT LOCATIONS AS SPECIFIED IN THE FIELD.
- 22. BUILDING SERVICE LATERALS (WATER, SEWER, ETC.,) ARE NOT SHOWN ON PLAN OR PROFILE AND SHALL, FOR THE PURPOSES OF THIS CONTRACT, BE CONSIDERED AS "KNOWN" AND TO EXIST TO EACH BUILDING.
