## I. Street Committee

# 1. 2021 Sidewalk Project

Ms. Houser shared that Ameron Construction began the sidewalk project on March 5<sup>th</sup> and completed it on July 16, 2021, well before the July 31<sup>st</sup> deadline. The project was awarded on February 22, 2021, for a total contract cost of \$768,467.00. Property owners who elected to install their own sidewalks will have 180 days from July 12<sup>th</sup> to complete their work. No exceptions will be made due to cold or inclement weather.

# 2. 2021 Paving Project

Ms. Houser reported that New Enterprise was awarded the 2021 paving project and received a notice to proceed commencing on July 19, 2021. The deadline for completion is September 28, 2021.

# 3. Center and High Street Signal

Ms. Houser reported that the audible alert for the walk/don't walk signal has been ordered and will likely be installed next month.

K. **Diversity Committee** – Mr. May reported that the Diversity Committee is supporting efforts to host a Spring Festival in Ebensburg next year, with the support of several local volunteer groups. The festival will celebrate diversity and the cultural heritage of our area. Details regarding timing and location are still under discussion.

#### L. General Business

## 1. PLCB Noise Enforcement Ordinance

Ms. Houser reported that since 2008, Ebensburg Borough has opted to enforce noise regulations at local licensed liquor establishments, exempting those establishments from PLCB's enforcement of noise violations. The exemption was last approved in 2016 and is due for renewal. Resolution #2021-02 was submitted authorizing that petition. A copy of the petition was included in Council's packet, along with a map of the exempted area and description of boundary lines.

Ms. Houser made a motion to adopt Resolution #2021-02 petitioning the PLCB to exempt Ebensburg Borough and licensed establishments from PLCB enforcement of noise violations. (May) Motion passed unanimously.

# 2. Cambria County Release of Claims

Ms. Houser reported that Cambria County and every county in the Commonwealth, was sued in a class action lawsuit by Chester County School District over fees charged to PA municipalities

for filing legal pleadings in the Prothonotary's Office. Upon review by the county, they determined municipalities were charged fees more than a ten-dollar limit. The county intends to reimburse all municipalities, which includes \$6.50 to Ebensburg Borough. They are requesting that the Borough release Cambria County and the Cambria County Prothonotary from any claim caused by the class action suit.

Ms. Houser made a motion to approve the release of Cambria County and Cambria County Prothonotary from any claim caused by the class action lawsuit filed by the Chester Upland School District against Pennsylvania Counties and local Prothonotaries, contingent upon the payment of \$6.50 to Ebensburg Borough. (May) Motion passed unanimously.

# M. Department Report

# 1. Police Department

Chief Wyland reported on the police department's activities during the month which included the placement of a Safe Exchange Zone at the Cambria County Courthouse and placement of restricted parking signs near the Memorial Field.

# 2. Public Works Department

Public Works Director Jeff Evans reported on the public works department's activities during the month which included the fish delivery at Lake Rowena and Jenks Dam, work towards a lead line replacement along High Street and working towards pinpointing water leakages to stop water loss.

## 3. Community Development

Community Development Director Danea Koss reported on the community development department's activities during the month which included the weekend's upcoming Downtown Shutdown and Homecoming, as well as updates on Concerts in the Park, the Farmer's Markets and Volunteer Appreciation Night.
