Item 8B: PENNVEST Requisition #8 is submitted for approval in the amount of \$20,184.47.

<u>Recommended Action</u> – Approve reimbursement request to PENNVEST in the amount of \$28,585.82.

Item 8C: Manor Drive and Lovell Park Sanitary Line Replacement The project includes the installation of approximately 3,500 L.F. of gravity sewer main and appurtenances along a backlot area adjacent to Manor Drive and Lovell Park, including reconnection of existing customer connections. The purpose of the project is to address structural deficiencies within the existing sanitary sewer mains which are resulting in excessive inflow and infiltration.

Bids were opened for the project on February 20th. Continental Construction was the apparent low bidder at a price of \$1,127,233.00

<u>Recommended Action</u> – Approve the project to proceed to the lowest bidder, Continental Construction in the amount of \$1,127,233.

Item 10F: Sidewalk and Curbing Project 2023:

This project was previously bid by the Borough in 2022, but since all bids came in well above the original cost estimate, the project was put on hold until this spring. New bids for the subject project were opened at noon on February 23rd. All qualified bids were accompanied with the required bid

bond. The total cost of the project is 136,827.88 with approximately \$4,500 coming from sidewalk funds with the remainder from the water or stormwater funds. Due to the fact that the majority of this is from stormwater, the Municipal Authority should agree to this for council to proceed.
