**PLEASE READ:**

**Security Deposits:** A \*\$50\* Security Deposit is required to secure a reservation at the YPCC. This includes a \$25 cleaning fee. All garbage cans must be emptied, and any additional garbage bags must be placed in the dumpster. (Additional garbage bags can be obtained at the YPCC). Failure to place garbage in dumpsters will result in the forfeiture of the \*\$25\* cleaning security deposit. **All fees must be paid in full at the time of the application.**

**Access:** Events scheduled at the YPCC or swimming pools will have access to the reserved area 30 minutes prior to the party's scheduled start time. All party attendees must leave the reserved area no later than 30 minutes after the party's scheduled end time. Any earlier set-up or later clean up at the YPCC or swimming pools will require an additional \*\$25\* fee. Pavilion rentals are for the entire day.

**Set up/Clean up:** At the YPCC, the Event Organizer is expected to set up the party with assistance from the staff (retrieving tables and chairs for the party). At the YPCC, Pool and Pavilions the Event Organizer is expected to place all trash and debris inside the dumpsters at the reserved area.

**Liability:** By signing this contract, you agree to indemnify and hold harmless YPCC and its employees for any damages, loss, or injury that may occur. Should the YPCC property be lost or damaged due to the activities of any of the party's attendees, your security deposit of fifty dollars\* or \*\$25\* will be forfeited.

**Cancelations:**

All cancelations must be received two-weeks prior to date of reservation to receive a full refund. Any cancelation received less than two weeks prior to date of reservation will result in a 50% refund.
